WAIVER AND RELEASE OF LIABILITY

NAME OF PARTICIPANT/MEMBER:

In consideration of being allowed to participate in any way in #playoutdoors activities and events, the undersigned acknowledges, appreciates and agrees that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death; and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist. The activities of #playoutdoors may include but are not limited to paddling, hiking, and other fitness activities and travel to and from such activities; and

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, OR OTHERS AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION OR MEMBERSHIP; and

3. I willingly agree to comply with the stated and customary terms and conditions for participation and membership. If however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and, I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS #playoutdoors, or any of its directors, members, officers, officials, volunteers, agents and /or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (all of whom or referred to as "Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

"The Participant agrees to pay all the costs and expenses (including legal fees on a solicitor and his own client basis) that #playoutdoors incurs with respect to any proceeding or suit taken by the Participant against #playoutdoors or the Releasees in relation to this Agreement or any of the activities that #playoutdoors offers."
